On Tuesday, September 5, 2017, colleges will receive a "bundle" of information on the listservs regarding guided pathways. All 114 community colleges are eligible to participate in the Guided Pathways Award Program, provided that representatives attend an IEPI workshop on the self-assessment process, complete a guided pathways self-assessment, and complete a multi-year work plan. Plans are in motion to assure that colleges receive ample support as this transformational endeavor begins system-wide. The information to be released next week provides all of the details about how to accomplish these first steps, including a timeline and an FAQ. Colleges can pdf a copy of the signed certification form and email it to curriculum@cccco.edu OR the original can be mailed to the Chancellor's Office, Academic Affairs Division. If the certification is not received by the due date, a manual review of credit course proposal will be conducted by the Chancellor's Office staff. Periodic reviews of these proposal types will be conducted by the Chancellor's Office in order to monitor data integrity. BASIC SKILLS INITIATIVE – ALLOCATION INCREASE, NEW FUNDING FORMULA, MONTHLY BSI COORDINATORS' WEBINARS

The Student Success for Basic Skills [Basic Skills Initiative (BSI) 2.0] budget allocation for Fiscal Year (FY) 2017-18 is \$50 million, an increase of \$30 million in on-going funds. BSI 2.0 includes a new funding formula, new program requirements, and additional allowable expenditures. Academic Affairs is in the process of conducting an analysis of program data to use with the new allocation funding formula. The advance allocation estimate for FY 2017-18 has been posted to the Academic Affairs [Basic Skills](#) webpage and will be amended within the next weeks to include an additional allocation, which will represent 75 percent of the total BSI funds. The allocation for the remaining 25 percent will be based on a certification colleges will receive this month, for submittal during fall 2017. Additional details will be provided to colleges within the coming weeks. [Education Code 88815](#) has the full text of the Student Success for Basic Skills program.

The Chancellor's Office Academic Affairs Division will continue past practice of hosting a series of monthly BSI Coordinators' webinars on the second Friday of each month. Due to a scheduling conflict, the webinar for this month will be held on Friday, September 15, 12-1 pm. Presentation topics include updates on the 2017-18 BSI 2.0 allocation funding formula and certification forms due fall 2017. Tentative BSI Coordinators' webinar dates for the 2017-18 academic year are: 9/15/17; 10/20/17; 11/9/17; 12/8/17; 1/12/18; 2/16/18; 3/9/18; 4/13/18; 5/11/18; and 6/7/18 or 8/10/18. CROSS ENROLLMENT IN ONLINE EDUCATION-ASSEMBLY BILL 637

CHANCELLOR'S OFFICE CURRICULUM INVENTORY 2.0

The Chancellor's Office would like to thank the colleges for their patience during the transition to the new Chancellor's Office Curriculum Inventory (COCI) 2.0. Although there still are bugs to work out with COCI 2.0, it is through the strong collaboration from all parties that COCI 2.0 will function at the level needed. Thanks to the input received from our colleges, staff, and the Community College CCC Technology Center, COCI is headed in the right direction.

The CCC Technology Center will soon be releasing 1.5.0, which will include: Activating Approved proposals with Control Numbers, CB01 as non-substantial change, and Proposals incorrectly marked as Deleted. This release will address more immediate concerns that affect the functionality of the system for both submitters and reviewers.

Following the 1.5 Release, the CCC Technology Center will focus on update 1.6.0 to address additional areas of concern. An announcement will be made prior to the release of both the 1.5.0 and 1.6.0 update detailing which issues they will address.

INMATE AND FORMERLY INCARCERATED EDUCATION

The Inmate and Reentry Education unit is now referenced as the Inmate and Formerly Incarcerated Education to align with college efforts and similar programs across the nation. As of fall 2017, 21 community colleges will be engaged in delivering inmate education across all 35 state prisons. To that end, the Chancellor's Office will rely on MIS Data student reporting for legislative reports. Please be reminded that MIS Data Element [SG04 Student-Incarcerated-Status](#) is used to collect student data and ensure that college data reported accurately reflect the number of students served. Be aware that college data are also made public using Data Mart.

While the Inmate and Formerly Incarcerated Program webpage is under construction, changes have been made to the [Resource](#) section. Information links have been added to the California Department of Corrections and Rehabilitation [Proposition 57](#) and the Opportunity Institute–Corrections to College California [Proposition 57 FAQ](#). Briefly, Proposition 57 allows non-violent offenders to earn Milestone Completion Credits and Educational Merit credits to qualify for reduce sentencing for service credits earned. The passage of Proposition 57 is likely to result in greater demand for courses and access to college programs.
