### CURRENTLY AND FORMERLY INCARCERATED EDUCATION

On October 15, 2018, the Chancellor's Office held a Conference of Colleges for those serving incarcerated students inside California state prisons. Brant Choate, Shannon Swain and Connie Gipson from the California Department of Corrections and Rehabilitation were on hand to field questions and Cerro Coso College shared some of their creative solutions to common issues. A conference for those serving the county jails and the formerly incarcerated will be scheduled in 2019.

Budget Assembly Bill 1809 provides for one-time funding of \$5,000,000 for California community colleges to establish or support programs serving formerly incarcerated students enrolled in community college, or providing face-to-face instruction to community college students in prison or jail. Watch for release of this RFA towards the end of November 2018.

### CAMPUS SAFETY AND SEXUAL ASSAULT

The Chancellor's Office has worked with Butte Technology Center to develop a listserv to facilitate communication between our office and individuals at colleges and districts who are involved with campus sexual violence. The Campus Sexual Violence (CSV) listserv ([csv@LISTSERV.CCCNEXT.NET](mailto:csv@LISTSERV.CCCNEXT.NET)) will mirror the functionality of other "Alias Lists" already in place. This type of list uses pointer functionality to forward messages to individuals based on employment positions determined by the college/district, and is maintained by college/district IT staff as personnel changes occur. Requests have been sent to local IT staff to create a mailbox for this list, and instructions for how to subscribe have been sent to local Title IX Coordinators to share with others at their college/district who work in this area.

The Chancellor's Office is continues to partner with the Office of the Attorney General to provide training for districts and colleges related to campus sexual assault. The free seven-hour training course will provide an overview of current developments in the law on campus sexual assault, the myths and realities of sexual assault, the neurobiology of trauma, student conduct procedures and fairness issues, evidentiary standards, confidentiality requirements, and how to conduct a sexual assault investigation and hearing. ## DISABLED STUDENT PROGRAMS AND SERVICES

The Chancellor's Office has released the detail on the first principal apportionment (P1) for the Disabled Student Programs and Services at each college. This calculation uses prior-prior weighted student counts. Starting with 2019-2020, new weights for the disability categories take effect and the base will raise to \$150,000. These changes were approved to recognize the difference in cost to serve specific disability categories and to support the recommendation in the regulations for certificated staffing in the provision of DSPS day-to-day operations.

### STUDENT SUCCESS METRICS

First release of the Student Success Metrics (SSM) dashboard will be available on October 31, 2018, which will include all the top-level metrics. The December 2018 release will include some of the disaggregation groups (Gender, Race/Ethnicity, Age Group, and Financial Aid Status). The February 2019 release will include an additional six disaggregations (First Gen, Foster Youth, Disabled Students, Veterans, LGBTQ, and Homeless) needed for Equity and for Vision for Success planning. The final 2018-19 release of the SSM dashboard will include the regional levels, cohort views, and the final six disaggregations (Transfer-level English vs. Transfer-Level Math, Retention at another college, type of Completion, and Transfer information). A series of regional training workshops on Student Centered Funding Formula (SCFF) and SSM are being scheduled for Spring 2019. These workshops will also highlight the alignment across various initiatives including Vision for Success, Guided Pathways, SCFF, SSM, and Student Equity and Achievement (SEA).
