Subject: 2001-02 Actual and 2002-03 Estimated Property Tax Revenue and
2002-03 Estimated Education Revenue Augmentation Fund (ERAF) for
Community College Districts

Synopsis: Attached are copies of the CCFS-329, "Local Property Tax Revenue for General Operating Support, Exclusive of Voter Approved Debt," for each community college district within your county. Education Code Section 84207 requires county auditors to report to the Chancellor of the California Community Colleges the actual property tax revenue received in the preceding fiscal year and the estimated property tax revenue for the current fiscal year for each community college district or portion of a district situated within the county.

Please report only that information applicable to your county. Other counties will report their portion of the property tax revenue distributed to multi-county districts.

Also attached is the CCFS-ERAF, "Education Revenue Augmentation Fund," to report the county's estimated ERAF, as well as the 1992-93 distribution of property tax revenue used to determine the community college proportional share of ERAF. Again, please report only that information applicable to your county. As soon as information is reported by all counties, we will notify each county auditor how the revenue from the community college portion of the ERAF is to be distributed among the community college districts. Hopefully, we will be able to make the preliminary allocations by the end of November.

For both the 2002-03 property tax revenue and the 2002-03 ERAF funds, please report the amounts estimated to be available and distributed to the community college districts on or before June 30, 2003 or soon enough after the end of the fiscal year to be recorded as 2002-03 property tax revenue.

Action/Date Requested: Complete the attached ERAF report for your county and a CCFS-329 for each community college district within your county and return them to the Chancellor's Office, Fiscal Services Unit, 1102 Q Street, Sacramento, CA 95814, on or before November 15, 2002.
