Local Goal Alignment in Legislation

In July 2018, the Student-Centered Funding Formula established a new funding framework as well as a requirement for local goal alignment [AB 1809, Chapter 33, Statutes of 2018]

Districts must establish goals that meet the following criteria:

- 1. Are aligned with the system-wide Vision for Success goals**
- 2. Are numerically measurable**
- 3. Specify the time for achieving the goals**

Local Action with Goal Alignment

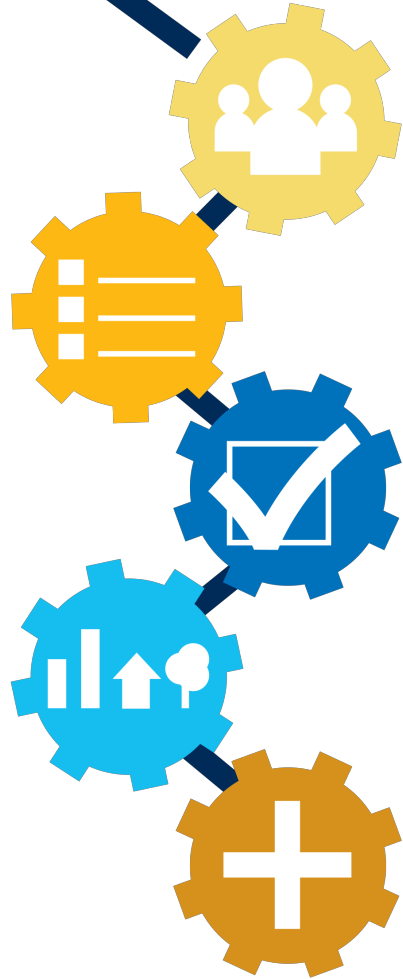
1. Adopt the goals at a public board meeting
2. Include an agenda item meeting that explains how the goals align and connect with system-wide goals
3. Provide the written agenda item and summary of action to the Chancellor's Office
4. Align its "comprehensive plan" to its local goals
5. Align its budget with the "comprehensive plan"

Timeline in the legislation specifies a January 2019 deadline, which will be addressed with item #2

Process for Local District Goal Setting

Review Baseline Data and Report Goals Development Process/Certification: November-December 2018
Certification by December 15, 2018 by the Chief Executive Officer

Set Local Goals: February-April 2019



Plan to Involve Board of Trustees:
October-November 2018

Review Existing Plans and Priorities:
January 2019

Adopt and Report Local Goals: May 2019
Goals due by May 31, 2019
With local signatories to the Chancellor's Office

Recommended Indicators for Goals: Simplified Metrics in Launchboard

Completion indicators: degrees and CCCC approved certificates

Transfer indicators: completed ADTs and transfers to UC/CSU

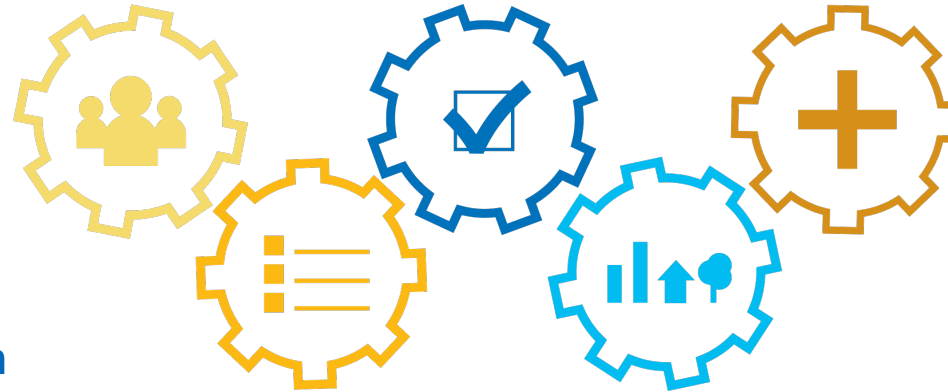
Unit accumulation indicators: Average units earned per completed degree

Workforce indicators: Median annual earnings of exiting students, number of exiting students earning a living wage, percentage of exiting CTE students who report being employed in their field

Equity indicators: Any of the above indicators disaggregated using locally identified disproportionately impacted populations in the Equity Plan and available in the Launchboard
