

Student Success Task Force Recommendations:

Implementation Work Groups

As the Chancellor's Office proceeds with implementation of the Student Success Task Force recommendations, we will rely heavily upon practitioner work groups to provide input and advice. Whenever possible, we will partner with existing advisory bodies that have historically provided our system with guidance and leadership within specific policy domains. These work groups will not serve as the sole venues for public input and vetting, rather, they will be the primary bodies to assist in the development of specific implementation details such as statutory and regulatory language. Once specific proposals have been developed, they will be presented and discussed in other venues, including other advisory groups, Consultation Council, and the Board of Governors. The input received in those additional venues will then be used to improve and refine the proposals.

The table, below, reflects the work groups that are currently active in developing implementation details for SSTF proposals:
