1. Overview of Strategic Vision Goal #4: CTE students who report being employed in their field of study – Van Ton-Quinlivan, Vice Chancellor of Workforce and Economic Development and Kathy Booth, WestEd (Informational Item)

The Board of Governors has tasked each Subgroup to examine one system-wide goal from pages 15-16 of the Vision for Success document found at foundationccc.org/Portals/0/Documents/Vision/VisionForSuccess_web.pdf. Goal 4 states:

Increase the percent of exiting CTE students who report being employed in their field of study, from the most recent statewide average of 60 percent to an improved rate of 69 percent—the average among the quintile of colleges showing the strongest performance on this measure in the most recent administration of the CTE Outcomes Survey. Improvements on this measure would indicate that colleges are providing career education programs that prepare students for available jobs and offering supports that help students find jobs.

2. Evaluation of Goal #4 and Recommendation to Board of Governors (Action Item)

The Strategic Vision Advisory Committee for Goal #4 will discuss, evaluate and develop a recommendation related to the adoption of Goal #4. The Committee's recommendation related to the adoption of Goal #4 will be provided to the full Board of Governors at its regular meeting on September 18 – 19, 2017.
