Note: The Legal Terms and Conditions state that: *all reports that fall on a weekend or a holiday are due by close of business on the last working day **prior to the reporting deadline**.* Extensions of reporting deadlines may be made with the approval of the Project Monitor.

May 15, 2013	The 2013-14 Perkins District Local Application (online) is due. <i>Note: Certification forms received by the CO before district applications for Perkins funds can be approved</i>
May 15, 2013	2013-14 Perkins - CTE Transitions Application (Paper) are due
July 1, 2013	Perkins 2013-14 Title I-C and CTE Transitions grants become effective. District/College Applications must be substantially approved by the CO prior to July 1, 2013 for expenditures to begin.
July 25, 2013	All 4th Qtr. Report for program year 2012-13 are due.
August 31, 2013	All Final Reports for program year 2012-13 are due.

Perkins Title IC and CTE Transitions 2013-2014 district allocations will be announced after the Chancellor's Office has received formal notification of the state's allocation from the California Department of Education per the Office of Vocational and Adult Education (OVAE).

2013-14 Perkins Title I, Part C Funding Information with related MIS deadlines

This memo provides deadlines and information critical to the 2013-14 Perkins Title I Part C (Perkins I-C) funding allocation under the Carl D. Perkins Career and Technical Education Act of 2006. Included are associated timelines for submission of Management Information System (MIS) data associated with the Perkins I-C funding and reporting.

Data Certification Forms Perkins Title I, Part C, Allocation for 2013-14

This memo provides notice of the 2013-14 Perkins allocation data reports and certification form availability and instructions for submitting forms. The reports are for district verification and certification of student counts used to determine the district allocations of federal Carl D. Perkins Career and Technical Education Act (Perkins – formerly VTEA), Title I, Part C, Section 132, Local Assistance funds.

Final Agreed Upon Performance Levels (FAUPL) Process

Beginning with the 2013-2014 Perkins Title IC Online Local Application, the 2013-2014 FAUPL negotiation worksheet will be combined with the Perkins Title IC Online Local Application's District Negotiation of Levels of Performance (CTE 6) form. In the new process, the State will calculate and propose new Local FAUPL Targets based on recent district performance.

Impact of Sequestration on Perkins

The US Department of Education has just posted estimated FY 2013 CTE State grant allocations with the 5.0% reduction based on sequestration. Carl D. Perkins Funding for 2-12-13 was \$124,509,075. Funding for 2013-14 is \$113,966,121, a reduction of \$10,542,954. Although California has received the state's estimated allocation, it has not yet been determined what the distribution will be between the CDE and the CCCCO. The final amount of each college's allocation will be determined and announced within the next two weeks. Until then, please use the 5% reduction for planning purposes only. Note: October 1 awards comes from advance-appropriated FY 2014 funds, which are not subject to the sequester.

Title I-B Advisory Committees

The \$38,000 funding for every Title IB Advisory Committee will terminate June 30, 2013. For the 2013-2014 program year, these funds will be used for Technical Assistance projects selected through a competitive Request for Application (RFA) process. RFAs

In addition to the newly posted Deputy Sector Navigator Grant Package, there are three RFAs posted at <http://extranet.cccco.edu/Divisions/WorkforceandEconDev/WEDDRFAs.aspx> that align with the Workforce and Economic Development Division's 2013-14 vision. These RFAs are:

1. The Regional Consortia Grant, due March 18, 2013;
2. The Sector Navigator Grant, due March 18, 2013;
3. The Centers for Excellence for Labor Market Research, due April 17, 2013; and
4. The Deputy Sector Navigator Grant Package, due May 3, 2013.

Over the next few months, the CCCCO will issue three new RFAs.

The **Carl D. Perkin's Funded Technical Assistance RFA** has an estimated release of April, 2013. The total funds available will be \$525,000 and the maximum number of awards is not yet determined. This funding may be used to build existing capacity, bring to scale best practices, form a community of practice with a definitive outcome and timeframe, provide professional development, and to fund those activities required by the California State Plan for Career Technical Education.

The **Industry Driven Regional Collaboratives (IDRC) RFA** has an estimated release date of April, 2013. The total funding available is approximately \$3,800,000 with the maximum number of awards to be determined. The focus of the IDRCs will be to convene skill panels to produce deliverables; develop instructional packages focused on the technical skills in targeted industry sectors; articulate curriculum model within a career pathway; provide faculty mentorships and staff development; support transformational activities focused on removing systemic barriers; deploy new methodologies that enhance performance and outcomes; implement projects to foster the growth of new businesses and jobs in emerging sectors; develop student internships; purchase equipment; and, submit performance data.

The **Governor's Career Technical Education Pathways Program (SB 1070) RFA**, or series of RFAs are estimated to be released beginning in May, 2013. Total funds available will be approximately \$30,000,000. The maximum number and categories of awards will be announced at a later date. SB 1070 supports activities that align with regional and sector strategies. The intent of the legislation is to fund projects that increase the readiness and success of middle school and high school students for postsecondary education and careers in priority economic sectors; promote productive partnerships between educational institutions and business and industry; promote and track participation of students in articulated courses; provide professional development to teachers and faculty; expand internship and work-based opportunities; support a Linked Learning program; and, validate measures to establish student readiness for postsecondary education and careers.

California Community Colleges Partners with United States Department of Agriculture for Rural Capital Readiness Program

California Community Colleges Chancellor Brice W. Harris announced that his office has entered into a partnership with the United States Department of Agriculture (USDA) Rural Development to increase access to training and higher education for rural citizens, support and enhance the agriculture industry and strengthen the state's rural economy.

Ten FREE "Capital Readiness" events have been scheduled throughout the state, at rural community colleges, to provide small and family operated farm owners, agriculture-related small business and small business owners in rural communities with information on how to access capital to grow their business and improve their local economy. Representatives from local lending institutions, USDA

Rural Development, the California Community Colleges' Workforce & Economic Development, the Business & Entrepreneurship Center (BEC) Program, the Small Business Development Center (SBDC) and the local community colleges will provide valuable information and resources that attendees can use to obtain loans and receive available services.
