Synopsis: This memo announces a change to the 2016-2017 Perkins CTE Transitions allocations from Carl D. Perkins Career and Technical Education Improvement Act of 2006 (P.L. 109-270; CFDA #84.048A) (attached)

ALLOCATIONS: The attached allocation detail shows a slight decrease in CTE Transitions allocations per college. We apologize for the inconvenience but inadvertently the newest college added to the Community College System in 2015 had not been considered when applying the formula for the CTE Transitions allocation which is based on an equal allocation for all colleges multiplied by the number of colleges within a district.
