SUBJECT: 2016-17 Perkins Title I, Part C and CTE Transitions District Final Allocations,
Online Application Availability and Core Indicator Reports

Synopsis: This memo announces the 2016-2017 Perkins Title I, Part C and CTE Transitions allocations of the Carl D. Perkins Career and Technical Education Improvement Act of 2006 (P.L. 109-270; CFDA #84.048A) (attached); Perkins Title I, Part C and CTE Transitions combined online application will be available for data entry; and the availability of the most recent Core and Indicator Reports (2016-17).

ALLOCATIONS: The attached document shows district final allocations for 2016-17 for Title I, Part C and CTE Transitions funding. The funding allocations were determined based on: 1) Categories of Unduplicated Headcounts by District and College (Final Report 1); and 2) The formula for the CTE Transitions allocation based on an equal allocation for all colleges multiplied by the number of colleges within a district.

COMBINED ONLINE APPLICATION: The 2016-17 Perkins Title I, Part C and CTE Transitions combined online application will be available for data entry on April 26, 2016. Templates for online local application forms were available to enable districts to begin the planning process and allow cutting and pasting of collected data once the online local application system is activated.
