## Program Highlight: Physical Plant and Instructional Support

#### **Allocation for 2018-19 PPIS:**

• \$5.464M allocated in advance apportionment

The two other funding sources are reappropriations that are pending budget line items from State Controller's Office in order to be distributed by First Principal (P1)



### Program Highlight: Physical Plant and Instructional Support (PPIS)

#### 2018-19 total PPIS allocations include multiple items:

- Senate Bill 840 \$5.464M (Available at advance)
- Senate Bill 840 (reappropriation) \$12.071M (Expected for P1)
- Assembly Bill 1825 (reappropriation) \$10.93M (Expected for P1)

Total 2018-19 Budget Act allocation - \$28.465M

# Student Equity and Achievement Program



## Student Equity and Achievement Program Ed Code 78222

- Intent is to support Guided Pathways and the system wide goal to eliminate achievement gaps
- Funds must be spent on student support services upcoming amendments to Trailer Bill may provide stronger language about the requirements for expenditures
- As a condition of receipt of funds a <u>district</u> shall comply with the following:
  - Maintain an equity plan per Section 78220
    - Despite the fact that CCCCO has not required districts/colleges to submit full plans since 2015-16, the district has the responsibility to update and approve Equity plans every 3 years
  - Provide matriculation services per Section 78212
  - Adopt placement policies per Section 78213 (AB 705)
  - Provide all students with an educational plan
    - More guidance coming



### Student Equity and Achievement Program

- 2018-19 Allocations are equal to the combined amounts of 2017-18 allocations for SSSP, BSI and Equity - \$475,220,000
  - Advance allocations were released early July
  - Advance will represent nearly all of the allocation, minor adjustments in P1
- Although allocation spreadsheet contained separate columns for SSSP, SE and BSI, the district is not required to adhere to those specific program allocations – the allocation is the sum of those amounts
- Districts may use up to 1% for faculty and staff development to...(help implement AB 705)—error in legislation to be amended soon



## Student Equity and Achievement Program

- Changes from 2017-18:
  - Allocations to districts, not colleges
  - No carve out for non-credit programs
  - No match required
- Flexible spending guidelines pointing to Ed Code, similar to 2017-18
  - SSSP, Student Equity for Basic Skills emphasis is on implementing AB 705
  - Reasonable and justifiable
  - No gifts, political contributions, stipends for students, FTES generating activities, and no supplanting (supplanting within SSSP, SE, and BSI is OK)



## Student Equity and Achievement Program Next Steps

- Develop proposed funding formula for future years
  - Discussions with Fiscal on composition of advisory body to assist with funding formula
- Review and revision of regulations of existing SSSP, SE, and BSI regulations
- Creation of new regulations and guidance, including requirements for educational plans
- Development of new reporting requirements upcoming amendments to Trailer Bill may address reporting



# AB 19 – California College Promise Program



#### <u>California College Promise</u> Requirements to Receive State Budget Funding

**K-12 Outreach.** Establish an <u>Early Commitment to College Program</u> to help students and families learn about college, visit campuses, take and complete college prep courses, and apply for college and financial aid.

**K-12 Partnerships.** Partner with LEAs to support college readiness and reduce remediation through evidence-based practices like learning communities or concurrent enrollment.

<u>Assessment and Placement Reform</u>. Implement evidence-based assessment and placement that improves outcomes for underprepared students, including multiple measures that utilizes student high school performance data. (See: <u>AB 705</u>)

**Guided Pathways.** Participate in the **Guided Pathways Grant Program**.

#### **Maximize Need-Based Financial Aid.**

- Leverage **BOGFW** "California College Promise Grant"
- Ensure all students complete the FAFSA or Dream Act application
- ➤ Participate in the federal loan program



## California College Promise AB 19 Funding Allocation

2018-19 Budget Act provides \$46 million to support California College Promise

#### Funding Allocation:

- 2016-17 Fee Waiver costs (\$36M)
- Pell Grant recipients (\$7.5M)
- FTES (\$2.5M)



## California College Promise

AB 19 Funding Authorized Expenditures

"It is the intent of the Legislature that funding provided to support the California College Promise be used by the community college to advance the goals outlined in Section 76396.1."

**Fee Waiver:** Colleges may (but are not required) provide a one-year fee-waiver for first-time, full-time students.

Full-time = 12 Units

First-time = IPEDS Definition

One Year = Fall/Spring (or quarterly equivalent), may add the summer prior to the fall term

Students must complete FAFSA or Dream Application

**Other Expenditures:** Local factors, such as existing tuition waiver programs or high levels of unmet financial need among low-income students, might necessitate other expenditure priorities.



### California College Promise Next Steps

Ongoing support for colleges re-entering the federal loan program (21 colleges)

College Promise "Certification Form" released and required to be submitted by 9/1/18

Partnership with IEPI on additional professional development and technical assistance Webinars announced Friday for August 16, 24, and 30.

Plans to hold a workshop to address best practices and strategies for coordinating program into and with local Promise programs.

New legislation recently introduced to expand the program to two years of "free tuition"
